COMMENTS:

Joyce Reed – Asked about the CBDG grant and now that the town has been awarded \$500,000 and we already have pre-qualified applicants, can people still apply? **Supervisor Geraghty** replied that at this time we are still getting all the grant process done and he believes we are working with the pre-applicants first and holding off on accepting any new applicants until we have more details after we meet with Flatley Read in the near future.

Jim Hull – Spoke about the CDBG Grant and stated that there is some misconception going around town that they're going to bring a Brink Truck in town and just hand out money. There are all kinds of hoops that need to be jump through to get any of this money and there is a lot to this process. **Supervisor Geraghty** replied that this will take some time before any work will start and some of the home owners on the Pre-application list may not be eligible for this grant but maybe for another grant that we can and will be applying for.

Jennifer Merry-Bierman – 10 Oak St - Asked about the water line and taking picture of it. Councilperson Rounds responded that where the pipe in your basement comes through the wall they would need a good color picture of it to be able to identify if its old galvanized or copper. If you have any issues you can call the Water Dept. and they will come out and take a picture for you.

Sheila Mender - Asked if the resolution to enter into an updated contract with Flatley Read for administrative services for the CBDG grant that was originally done in 2022 going to cost the town more money for this update? **Supervisor Geraghty** responded that he believes this would be just a change in language and dates.

Bryan Rounds - Spoke about the Warren County Tax Auction that Warren County has every year and how some properties get sold and 50% of them that get sold are being worked on and fixed up and some don't do anything with them and just put a for sale sign on them. He would like Warren County to start leaning on the bidders at the auction to do something with them. **Supervisor Geraghty and Jim Hull** stated that there was a law that got passed and the committee at the time said it was 18 months from the time that they purchased it to get a Certificate of Occupancy (CO) on the property, but Jim believes that the county changed it to 2 years.
