Report details:

The process of reviewing sales that have occurred during the last sales cycle (July 2024 – June 2025) is currently underway. These sales are used to establish the equalization rate for 2026 Assessment rolls. During the upcoming months, we will be working closely with the Office of Real Property Tax Services (ORPTS) utilizing the outcome of these sales to arrive at the 2026 equalization rate. This process involves reviewing and analyzing the selling price compared to the assessed value at the time of sale plus other factors and sale conditions that may or may not have an impact on the validity of any given sale (i.e. true Arms-Length sales, sales between family members, neighbors, bank pre-foreclosure sales, distress sales, estate sales, etc.). This will continue for the next few months along with reviewing and assessing new construction properties.

December 2025 Sewer Report

Cleaned all the chemical feed lines out and replaced any valves that were not working. Changed out one of our chemical tanks with a new one.

Our new baffles for the lagoons have finished the manufacturing process, shipped and have arrived at the sewer plant.

Pulled apart one of the pumps at pump station B due to it being full of rags. The pump was cleaned out, inspected and put back online.

Cleaned the sand filters, both filters needed to be air and lanced to get the sand moving evenly. Everything is working well now.
