WHEREAS, the <u>Town of Warrensburg</u> desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of Construction

NOW, THEREFORE, the <u>Town Board</u> duly convened does hereby

RESOLVE, that the <u>**Town Board**</u> hereby approves the above-subject project; and it is hereby further

RESOLVED, that the <u>Town Board</u> hereby authorizes the <u>Town of Warrensburg</u> to pay in the first instance 100% of the federal and non-federal share of the cost of Construction work for the Project or portions thereof; and it is further

RESOLVED, that the sum of **\$333,000.00** (three hundred thirty-three thousand) has hereby appropriated from the <u>Highway Fund</u> and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, the <u>Town Board</u> shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof, and it is further

RESOLVED, that <u>Town Supervisor</u> be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the <u>Town of Warrensburg</u> with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible, and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project and it is further

RESOLVED, this Resolution shall take effect immediately

To let the public, know that the town did pass another resolution back on June 12th 2024 that allocated another \$560,000.00 from the same contract number that will go towards the paving of Rt. 418 known as River Street from the Osborne Bridge all the way to where the sidewalk ends. The town and state has already passed three phases that has allocated extra money towards this project that will continue into 2025.

with the revised project description to include the additional phase 2 items including a new small diameter (small 6" or less) water main replacement for Jenni Jill Loop to increase water pressure for an undersized system that is currently fed by a 1" copper line and water tank upgrades including security fence, valve vault vent, replacement of valving and appurtenances in valve vault, and new cathodic protection; and

WHEREAS, thereafter, notice of the Town Board's intention to serve as Lead Agency was duly provided to all Involved Agencies together with Part 1 of a Full Environmental Assessment Form (FEAF) and other Project-related information; and

WHEREAS, more than thirty days have elapsed since Involved Agencies were provided with such notice and no Involved Agency has objected to the Town Board serving as Lead Agency.

NOW THEREFORE BE IT RESOLVED, that upon review of all information contained in FEAF Part 1, all Project related data, upon consideration of each relevant question posed in FEAF Part 2 and after analyzing all potential environmental impacts that might result from water main replacement in the FEAF Part 3, the Warrensburg Town Board hereby finds that there will be no significant adverse environmental impacts resulting from the Project and hereby adopts a SEQRA Negative Declaration; and be it further

RESOLVED, that Town Engineers, Town Legal Counsel, Town Clerk and Town Supervisor are hereby authorized to undertake all actions necessary to effectuate this Resolution including making all necessary filings of this Negative Declaration.

COMMENTS:

Supervisor Geraghty stated – 1^{ST} : Back a while ago the board had discussed borrowing a lot of money for the street lighting and buying the fixtures and after further review the town decided not to move forward with NY Power Authority but did pay for a minimum amount for engineering work. Supervisor Geraghty contacted National Grid and they proposed the outlay for the town would be in the \$50,000 to 60,000 range to get them to replace all the lights with LED's and then within a year's time we would get at least 50% back in savings. Supervisor Geraghty has written a letter to National Grid community and customer manager and let them know that the town would like to move ahead with their plan and they will supply him with specifics on the cost after review by their attorney's office and then the board will do a resolution to go ahead. Supervisor Geraghty stated that they believe it is better for the town as they won't own the fixtures so in turn the town won't have to pay to fix the fixtures.

 2^{ND} - There are a lot of projects the town is trying to get accomplished this year and we are running into roadblocks in getting the sidewalk and the crosswalk put in from the Richards Avenue parking lot over to the Health Center. The construction firm the town was trying to work with finally got back to Supervisor Geraghty and their engineer had not gotten back to them, so Supervisor Geraghty contacted Cedarwood Engineering and they drew up the plans for the sidewalk and the goal is to get that done before the paving of Richards Avenue parking lot this year if possible and the Health Center has agreed to help pay for the paving of the parking lot as well. The other paving projects are moving ahead and the Highway dept. is doing a good job on getting them done.

 3^{RD} - The town was hoping to get funding from the State to help all the people that had damage to their property and homes during the hurricane, but unfortunately we didn't qualify for Federal funding and Supervisor Geraghty doesn't believe there will be any funding for the homeowners in Green Mansions or anybody who was extremely impacted by that storm. This was very disappointing even though the town

had the NY State Representative here to tour and assess the damages, but this is all based on the total losses on a Federal level. Supervisor Geraghty stated he will still reach out to our two area Representatives to see if there is any funding available anywhere from the State that we could try to get to help the people who were impacted by that hurricane.
