May 2025 – EMS Report

DISCUSSION: Supervisor Geraghty asked board member Robert Sutphin if he wanted to go ahead and try to decipher what is on the EMS report. Councilperson Sutphin stated he sees they finally posted a report and everybody got a copy, but he was not sure how much of this information he is allowed to put out there and if there is a rule or regulation on what can be talked about. Attorney Jackie White stated she has not seen it so she can't help with that. Supervisor Geraghty suggested councilperson Sutphin could see how many runs they made and how much money they made at the end of the month. Attorney Jackie White stated that the town is not required to read any of the EMS reports at the town board meeting, this report is just required under the contract for the EMS to provide to the town and it is your choice to share it if you choose to. Councilperson Sutphin proceeded in reading the cost statistics for January through April and has found that the totals that were reported are wrong. In January the total call volume was 204 and if you add up the numbers on the list it's 190, same with February the total call volume as reported is 181 and when added up its 165. In March total calls 211 and when added up its 202 and April is incorrect as well. On the financial highlights in March to April total accounts has a difference of \$12,915.00, So there's a question as well. Councilperson Sutphin also stated, he wished he had gotten a heads up from Supervisor Geraghty that he wanted him to present the EMS report and he certainly would have been more prepaid for it.

DISCUSSION: Attorney Ryan Pazulo stated, he represent Charles Ligon and is before the board this evening seeking an approval for an open development space under section 28A of the town law for the property know as 9 Browns Court. His client owns a vacant piece of residential property and he would like to get a permit to put a single family home on that property which has a deeded right of way for access to the property. Attorney Jackie White responded, Mr. Ligon has been in front of this board previously and has also been in front of the town Planning Board. Previously the town board did not act on this request and therefore it went into litigation and the Town Attorney received a decision from the court judge that basically said it's got to go back in front of the town board to make a decision one way or the other. The only questions were about the fire protection if a fire truck had difficulty getting in to the property. Attorney Ryan Pazulo stated that the property is within the fire code radius to a fire hydrant and the right of way access is actually 10 ft wider than the minimum required.
