**OPEN PUBLIC HEARING AT 7:05 PM:**

**Public Hearing on No parking at the Circle Parking Lot in the Warrensburg Upper Hudson River Management area. Also, a request to set a speed limit on the road (River Road) at 25 MPH. Setting a weight limit on the road should be withdrawn at this time.**

Town Clerk, Pamela Lloyd read the Public Hearing Notice that was published on June 19, 2025 in the Post Star Newspaper

**PUBLIC COMMENTS :**

**Jamie Johnson, owner of Tubby Tubes in Lake Luzerne** - He introduced himself and expressed his willingness to work with everybody and the town to collaborate a solution for the use of River Road, and very thankful and appreciates being able to use River Road for his business.

## **REGULAR TOWN BOARD MEETING – JULY 9, 2025**

**David Beaury, a lifelong resident of Lake Luzerne** - He emphasized safety concerns due to increasing congestion and unruly behavior on the narrow dirt road. He supported the proposed restrictions, including weight limits, citing safety of the people and environmental degradation should take precedent over the Tubing Company. He spoke about and supplied a 3 page petition that was printed from an online website stating there were 59 verified signature with only 3 featured comments supplied.

**Jamie Rozell, Manager of Tubby Tubes River Co.** - She highlighted the company's commitment to safety as their biggest priority, noting their local drivers adherence to low speeds and efforts to keep the area clean and safe. The guest enjoy coming out and seeing the Hudson River and they have just as much rights as everybody else. When they bring their guest to River Road it takes roughly 15 minutes to unload and the bus is completely pulled over so other traffic can pass freely. Tubby Tubes River Company have been providing tubing enjoyment for this area since 2002 and would like to continue doing so.

### **TOWN BOARD COMMENTS:**

The board acknowledged the need to balance safety with the business interests of tubing companies. They discussed potential solutions such as creating off-road parking areas for the buses during unloading and pickup to prevent roadway blockages. The limitations imposed by environmental regulations (DEC) on road alterations were noted, and the board expressed intent to cooperate with all stakeholders. Enforcement by forest rangers was seen as crucial for the effectiveness of regulations. Concerns about the narrow road sections where two vehicles cannot pass safely were raised, with suggestions about closing the road completely to vehicles debated but ultimately dismissed in favor of finding a middle ground. The public hearing closes with the board committed to working towards a compromise that prioritizes safety while allowing tubing/rafting companies to operate.

Carver Construction, Inc - Resurface @ \$52,174.00 – Paint/Line @ \$20,000.00 – Total \$72,174.00

HMA Contracting Corp - Resurface @ \$46,560.00 – Paint/Line @ \$27,100.00 - Total \$73,660.00

The board, per the suggestion of Councilperson Bryan Rounds decided to accept the lowest responsible bidder for each task separately as that is how the Bids were presented in the Notice to bidders published. Resulting in HMA Contracting Corp accepted for Resurface Bid and Carver Construction, Inc accepted for Paint/Line, recognizing that the bids were separate and contractors might decline partial contracts. The motion passed unanimously.
