OPEN PUBLIC HEARING AT 7:05 PM:

<u>Supervisor declares Public Hearing open on the proposed 2026 Preliminary Budget – privilege of the floor extended to anyone wishing to be heard on this matter.</u>

Town Clerk Pamela Lloyd read the Public Hearing Notice that was published on October 2, 2025 in the Post Star Newspaper on 2026 Preliminary Town Budget.

Supervisor Geraghty read a synopsis of the 2026 Preliminary Budget proposed appropriations, revenues, and tax implications:

- Total appropriations for general and highway funds combined are approximately \$3.82 million, reflecting an increase of about \$83,000 from previous year.
- Total revenues are forecasted at \$1.93 million, up by roughly \$51,500 compared to last year.
- The town plans to use approximately \$44,381 from the fund balance to balance the budget, which is slightly higher than last year's usage.
- Taxes to be raised to \$1.45 million, marking a \$50,000 increase over 2025, mainly driven by increased health insurance, retirement costs, and pay raises.
- The town tax rate is projected at \$2.919 per thousand, a 7.5 cents increase from the previous year.
- The lighting district saw a significant decrease in appropriations to \$86,000 due to the installation of LED lights, reducing costs by \$24,000. Correspondingly, the tax rate in this district will decrease by 7.2 cents per thousand, effectively a slight tax reduction for residents.
- The ambulance district budget increased modestly by \$10,000 to \$410,000, resulting in a 1.2 cents per thousand tax increase.
- The overall budget remains under the state-mandated tax cap, continuing a trend of fiscal responsibility.

Councilperson Alexander stated Supervisor did a marvelous job with another successful budget and keep under the tax cap, he believed the reevaluation of property helped as well, along with some new businesses in town to increase the sales tax. Also moving forward with National Grid in changing the lighting to LED has already saved the town a lot of money.

Councilperson Alexander also stated he wanted to make a change to the Preliminary Budget and asked Supervisor Geraghty to recuse himself from the rest of the discussion. John wanted to state that he has been on the board for 20 years now and this is his last year and it has been one the biggest honors of his life doing this for the taxpayers and the community and working with the Town Board and especially working Supervisor Geraghty, which they started at the same time. The town is in good fiscal shape and after all the things that the board has done under Supervisor Geraghty's leadership, Councilperson Alexander would like to make a motion to increase the Supervisors salary by an additional 3%.

Councilperson Sutphin stated he means no disrespect to the board members or anybody like that, but we just got done raising the rates on the Water and Sewer and the property tax increase due to the property reevaluations, he believes it would be wrong to increase Supervisors salary at this time.

We will be able to discuss the possible sale of this property with our goal of having a developer construct senior housing on the site in the future.

We received a request from Community Members for the Town Board to review our current law on short-term rentals in the Town. We should schedule a workshop meeting in the future to have discussion on the subject and seek further input from the community.

OLD BUSINESS: Richards Avenue parking lot paved today.

I will attend a meeting with the Chamber of Commerce to critique the recent World's Largest Garage. Again, the Town crews did an excellent job of cleaning up the during and after the sale. 7.8 tons of garbage were collected during this year's sale down from last year's 8.96 tons. I would ask the Town Board members and public to bring any concerns to myself or the Chamber.

Gary Cooper from Lake Ave asked what is considered non-conforming? Attorney Jackie White responded, this Local Law would not apply to the people in the overlay district only the ones outside the district that are non-conforming apply.

<u>Karl Duell</u> - stated that the ATV that his brother and himself were riding in during garage sale weekend is legal with a state-to-state reciprocity. He will be going door to door and let residents know he could make a difference as a town board member and he has a lot of fresh ideas and has reached out to some of the other board members and has gotten no response and he represents a younger generation and believes that he can bridge the gap with the younger generation.

Amanda Bruce 6 Pasco Ave - Stated that she is new to Town and has been here only a few year now was and saw that Mr. Geraghty had commented on something in a local paper about an issue of nitrous oxide being sold in the smoke shops and wanted to bring up the issue of Kratom being sold in the smoke shops as well. She is nervous because these businesses in town are important, but as a mother she is concerned that these products are being sold in the town and if the people are aware and was hoping to get together as a community and think of some solutions. Kratom is being marketed as a natural product and similar to coffee, but it is actually being used similar to methamphetamine and opiates. She is just thinking about the children in our community and what we are messaging to them. Supervisor Geraghty asked if she could bring some information to him on this and he will bring it to supply it to Warren County Health which in turn has been imploring the state to do more with the smoke shops to curb some of these sales of these products.

Gary Cooper 87 Lake Ave - Stated that he was glad this was brought up. About 8 to 10 years ago there was a smoke shop where the barber shop is and they were selling glass pipes and the town shut them down. Why now can we have these two legal smoke shops and why is our zoning board allowing this obnoxious lighting? He has had several complaints brought to the town board to have these bright lights shut down. Gary also thanked John Alexander for his 20 years plus of service and stated that its going to be sad to see you go.

DISUSSION: Thomas Hutchins, P.E. Hutchins Engineers of Queensbury, Stated he was here representing the property owners, Nicholas McCarrol of 412 Alden Ave in reference to an on-site septic system that's in failure and needs to be replaced. It has been ailing for some time now. The property is 1.4 acres and there is enough room its long and narrow and bounded to the south by a stream that runs through the central portion of the property. To the west is a steep rock mountain and there is drilled water supply well. Right now the current system is 35 plus feet from the brook. They would like to take that absorption area and relocate it to the northern portion of the property and will maximize the distance from the stream and existing well, that we can with the physical constraints of the property. They are proposing a somewhat enhanced treatment system in Elgen sand filter system which provides a higher degree of treatment than a conventional system. It will be 50 feet from the existing well, however it is quite a bit downgrading it from that well and with the enhanced treatment they are proposing a home residential style ultraviolet disinfection system on the water supply in mitigation for not being able to meet the 100 foot setback from the well to that absorption field. They are looking for support from this local board as this is a replacement system. Some of the Board members were suggesting to have the Town Engineers take a look as a second opinion. The Town Attorney Jackie White stated she believes this is subject to a public hearing as per the town code. Supervisor Geraghty stated they will schedule a public hear and have the Town Engineer take a look at the plans.
