The Board went on to the matter of old business, which is an amendment to SPR #2023-2 by Bandstand Brew Works.

Neighbor, Catie Persons, stated that she met with Darby Langworthy and they came up with a solution to her concerns regarding customers of BSBW using the existing curb cut, including putting a stop sign on right-of-way at the exit point of the brewery's parking lot and putting up a fence separating parking lot from driveway.

Darby agreed with Mrs. Persons and went on to explain that they will be installing a split rail fence where she indicated and

they will be striping the driveway (right-of-way) after they widen and pave it.

Mr. Franchini asked who maintains the right-of-way. Mr. and Mrs. Persons indicated that Mr. Persons and Bandstand Brew Works both plow it.

Darby discussed that they will be demolishing the house. He was the one holding out in favor of renovating; however, it will just be too costly.

Mr. Franchini asked how they are going to keep people from leaving the property (over the sidewalk) where they originally wanted curb cut. Darby indicated that they were going to be installing split rail fencing up front as well.

Mrs. Hull asked if they would be planting any bushes up in front. Darby indicated that yes, he would be.

Mrs. Persons asked if these items would be made conditions of the approval and the Board indicated, "yes". And Mrs. Corlew also suggested that the applicant indicate on the plans tonight the additional changes to the site plan.

Mrs. Sutphin asked when the house would be demolished and Darby indicated that he wasn't sure, but they would first like to widen the driveway, pave and install the fencing before demolishing the house. Mrs. Sutphin asked when that would be completed by. Darby indicated it depends on the weather but said it should be complete in the Fall and that they would not start until after the Garage Sale.

Mr. Franchini questioned whether they would be paving the parking lot and Darby indicated that they will be doing that. Mr. Franchini asked about drainage and Darby indicated that they would be installing a drywell.
