The Board went on to the matter of site plan review #2023-3 for North Country Ministry. Mr. Curt Dybas and Ashley were here representing the organization on this application. Mr. Dybas went over the final site plan. The first sheet shows the existing conditions, the second sheet shows demolition and removal and the third sheet shows the new layout with the two additions and 16 parking spaces. He stated there will be permeable pavement and that the turnover on the site is fairly quick. The fourth sheet shows the grading where it indicates where the water's going to go. He indicated that they did leave an area in front where they can push some snow to in the winter, but if it piles up, it will have to be removed. The fifth sheet shows the planting but there won't be much planting.

Mr. Fortino stated that he is satisfied with the final plans.

Mr. Dybas stated that the new plan improves the sight distance aspect compared to what's existing now.

Mr. Fortino made a motion to approve the application with work to be done according to the plans submitted on March 12, 2024. Mrs. Tyler seconded the motion. All three members voted in the affirmative.

The Board moved on to application #2021-2 by Michelle Brown, LLC for expansion of the Warrensburg Travel Park campground by adding 51 campsites. Representing the campground is John Hitchcock from ABD Engineers.

Mr. Hitchcock stated they've reduced the amount of campsites they are adding. They went through the APA and DOH processes. They received APA approval on December 7, 2023. The APA required the applicant to have a 150 foot buffer from delineated wetlands. He went on to state that the 8 campsites that were proposed in the Business Industrial zone (which they had gotten a variance for) are no longer being proposed. They produced a storm water plan and reduced the 68 campsites in the OH zone to 51. They received approved from the Department of Health on March 12, 2024. There will be water run to the sites. There will not be sewer run to the sites. They will have a Honey Wagon to collect sewage from the RV's. They are adding a 2,000 holding tank to the existing 3,000 holding tank. They will also be adding porta-potties to meet Department of Health code.

The board was satisfied with all of the information on the plans, so they moved on to go over Part 2 of the Short Form of SEQRA. The Board determined that this project will not result in any adverse environmental impacts. Mr. Fortino motioned, Suzanne Tyler seconded and all members voted in the affirmative.
